- Photo copies submitted for each of the documents should be clearly readable.

- For Non-Residents and foreign nationals, copy of passport / PIO card / OIC card and overseas address proof is mandatory.
- · Details mentioned should be in the block letters.

- Bank account details & signature on all payment instruments should tally with the bank records of the member (as submitted to the bank).

MEMBERSHIP RULES

- During festival seasons like christmas new year and weekends of summer vacations room will be available but one night will becut off from the remaining days
- 2 The booking time can be from 90 days to 10 days before the date
- Two nights will be offered as gift in the same resort by the membership holder to the third person(family consist of 3 adults or 2 adults and 2 kids below 12 years)
- 4 The cancellation should be done 5 days prior to the date to avoid the lapse of nights
- 5 If the cancellation is done in between these 5 days of booking date the nights will be lapsed baned on the cancellation policy

1 Membership Usage Rules Entitlements to CVH

The Membership Usage Period shall commence as under:

- · Full Payment Member-Immediately after one month from the end of the month of admission as a member.
- . Member opting for 6 EMI plan-Down payment and 1 EMI Realization.
- . Member opting for 12 EMI plan-Down payment and 2 EMI Realization.

2 Utilization of Entitlement

- * Member can request for Holidays starting from one day to a maximum of 7 days. Any number of requests can be made during a year. Subject to availability, CVH shall confirm the Holidays requested by issuing Confirmation Voucher.
- * The number of occupants in Studio Apartment shall be 3 Adults and in One Bed Room Apartment shall be 4 Adults. Two Children below the age of 12 years shall be considered as Adult. The Children above 12 years old shall be considered as an Adult.
- * Member can request for additional Apartment, down-gradation or up-gradation of Apartment subject to availability.
- * Member or Holder of Confirmation Voucher shall comply with House Rules of the Resort.
- * The unutilized days at the end of the Membership Period shall lapse.

3 Scheme of Holidays

- 3.1 A calendar year is divided into 2 seasons namely (a) festival season and (b) Mid season.
- 3.2 A Member is entitled to enjoy a minimum of 1 Day (1 Night and 2 Days) and a maximum of 7 Days (7 Nights and 8 Days) in the season and apartment purchased during one holiday in a Year.

4 Process of Availing Holidays

- 4.1 A Member can avail of a holiday by giving a request for reservation in a form(s) as may be prescribed by CVH
- 4.2 All holiday reservations shall be done on a first-come-first-serve basis and are consequently subject to eligibility and availability. Request for reservation can be done from 3 months (depending on the prevailing reservation rules) to the commencement of the holiday.
- 4.3 On confirmation of the availability of the holiday period requested for by the Member, CVH shall issue a confirmation voucher specifying the reservation details including check-in and check-out time to a Member for enjoyment of the holiday. The Member shall abide by the terms and conditions mentioned in the confirmation voucher.
- 4.4 No request for transfer of confirmation voucher shall be entertained by CVH.
- 4.5 Notwithstanding anything stated herein above, CVH shall not incur any liability if it is not in a position to fulfil its obligations by reason of any war, civil commotion, force majeure, act of God, other notification from any Court of Law or Government or any other reason beyond the reasonable control of CVH.
- 4.6 CVH may levy a waiting period of not more than 60 days for an eligible member to start their holiday entitlement.
- 4.7 As per the applicable Government Guidelines / Know Your Customer (KYC) norms, the member is liable to submit the required Government issued documents towards his / her / its proof of address and identity at the time of check-in at the CVH.

5 Privileges

- 5.2 Confirmation Communication: Any Holiday requested for by a Member would be subject to specific confirmation communication like a confirmation voucher, e-mail, letter that will be issued by CVH. Please note that all requests for holiday are subject to eligibility and availability.

6 Confirmation Voucher

- 6.1 Member can request for cancellation of confirmed Holiday subject to such terms and conditions stipulated by CVH at the time of request.
- 6.2 The Confirmation Voucher is non-transferable.
- In case for any reason Holidays could not be provided in the Resort for which Confirmation Voucher is issued, CVH shall provide Holidays in alternate Resort/Hotels/Location.

7 Payments

- 7.1 Member shall pay the Membership Fees as per the Price Structure offered by CVH. In addition to the Membership Fees, Member shall pay applicable Taxes and Levies.
- 7.2 Member shall settle and make all payments including taxes and levies for food, beverages and other services availed at the Resort.
- 7.3 The taxes and levies paid are not refundable on any account whatsoever.
- 7.4 All payments towards Membership is to be made only by Cheque / Demand Draft / Automated Clearing House / Standing Instruction / Credit Card/Debit Card.

8 Eligibility

The Member who has paid the Membership Fees in full is eligible to request for Holidays after the issue of Certificate of Membership subject to waiting period as may be stipulated by CVH from time to time. However, Member who has opted for installment scheme is eligible to request for Holidays after the specified period stipulated by CVH which varies as per the Payment Plan opted for by the Member.

9 Resorts

- 9.1 The Resorts in which Holidays are provided by CVH are leased / licenced / tie-up or owned. The Facilities, Amenities and Services could vary from Resort to Resort. The tariff and charges for the facilities, amenities and services will also vary from Resort to Resort.
- 9.2 As the Resorts are leased / licenced / tied-up or owned, the size and specifications of the Apartments will also vary from one Resort to another.

10 Cancellation

- 10.1 The Member is entitled to cancel the Membership within 10 days from the date of application of Membership and obtain full refund of the payment made subject to deduction of Cost of Holidays availed and Cost of Promotional Offers, if any.
- 10.2 After the expiry of 10 days, Member is not entitled to refund of the Membership Fees on any account whatsoever.
- 10.3 In case of default in payment of any instalment, CVH reserves the right to levy interest on such delayed payments or cancel the Membership.
- 10.4 Withdrawal of Application for Full Refund:
 - Members are allowed a period of 10 calendar days from the date of application of Membership to withdraw their membership application and claim a FULL REFUND. If the application of withdrawal duly signed by the Member (in case of Joint application both the Principal Member and Co-applicant) is not received by CVH within the 10 calendar days from the date of application of Membership, the Members' right to claim the withdrawal and the Members' entitlement to FULL REFUND shall lapse. For the purpose of making this important communication on time, CVH recommends Member to use Registered E-mail ID / Speed Post / Registered Post / / Courier Services for communicating with CVH shall refund the amount within 60 working day from the date of receipt pf vaild request for withrawal of application.
- 10.5 All requests for cancellations shall ordinarily be in writing and signed by the Member / Authorised Signatory and both members in case of joint applications / Company.
- 10.6 Appropriation of Payments: In case of part payment made by the Members towards any outstanding shall first be appropriated towards interest and then earlier dues / outstanding.
